

Abstract Guidelines

All entries should fall under one of the below categories:

- Liver cancer – the impact of etiology
- Early hepatobiliary carcinogenesis
- Tumor cell microenvironment and immune mediated mechanisms of hepatocarcinogenesis
- Microbiome and tumor metabolism
- Tumor cell plasticity
- Genetic and epigenetic alterations and targeted therapies
- Innovative therapies and novel therapeutic approaches
- Others

All abstracts should be submitted electronically via the Conftool system before the abstract submission deadline. All abstracts must be submitted by **30 June 2023**. The abstract should fit into **1.5 Din A4 pages**.

Please do not use any other document than this Word document (https://verwaltung.unikt-kongresse.de/wp-content/uploads/Abstract_Template_HCC2023_1.docx) for abstract submission. **Please do not change the formatting of the template and please follow the given formatting exactly.** Submissions that do not comply with the specifications cannot be processed.

Please save the final Word document with all graphics and tables as a **PDF file** and submit it via the Conftool abstract system (<https://www.conftool.com/hcc2023/>). Graphics and tables can additionally be uploaded separately in the system.

It is important that you **first create a user account in the system**, after which you can **register for the conference** or **submit your contribution** via the system.

The abstract text must also be entered separately into the Conftool system.

It is **necessary to enter and mark the presenting author** in the system.

In addition, the following requirements must be observed.

The maximum length of the **title** is **300 characters** (including spaces)

The maximum length of the **text** is **3,000 characters** (including spaces, without References and Support & Funding)

The abstract may include a maximum of 1 table and 1 graphic/figure.

If you use tables or graphics, please subtract 300 characters for graphics and 50 characters for tables from the total text (3000 characters including spaces).

Abstracts should be written in **English**.

If you are experiencing technical difficulties submitting an abstract, please contact the [Congress and Conference Management \(Unikt\)](#) for assistance.

Submission(s):

- All abstracts must be submitted online through the abstract submission system by the posted deadline to be considered for acceptance. No fax copies, disk or e-mail submissions will be accepted.
- Only the individual listed as the official contact of the submission has authority to withdraw it or revise content. If an abstract must be withdrawn after submitted, request must be received no later than 30 June 2023. To withdraw your abstract, email unikt-kongresse@zuv.uni-heidelberg.de. Please include your name and abstract title.
- Submission of an abstract constitutes a commitment by the author(s) to present their work if the abstract is accepted.
- Presenters must register for the Liver Cancer Research Conference 2023 and are responsible for all personal expenses related to the meeting.
- Authors are responsible for providing a substitute presenter if the presenting author is unable to attend.
- All presenters are required to disclose any financial and non-financial conflicts of interests.
- We will offer you a list of copy shops on the website near the congress venue where the poster can be printed for the congress.

By submitting an abstract, the authors certify that s/he has written consent for use of any recognizable photographs in posters or presentations.

Authors should be aware that abstracts will be published as submitted without copyediting. If accepted all spelling errors, grammar, misspelled author name/credentials, will be published as submitted.
